The English Proficiency Requirement for Graduation for each undergraduate student of the College is the exam score report of B2 level of CEFR (Common European Framework of Reference for Language) (equivalent to TOEIC score of 785+, IELTS score of 6.0+, OPT score of 61+, TOEFL iBT score of 72+, or GEPT High-Intermediate or better) obtained prior to the 2nd semester in the 3rd year of their study in Fu Jen.

Students who do not meet the standard prior to the 2nd semester in their 3rd year are required to (1) participate in the Autonomous English Learning Project and take at least 4 tests each semester in their 4th year. Students who achieve the average score of 80+ in the 1st semester tests or have accumulated 4 times test scores of 80+ during the 2 semesters can waive the remaining tests. Students who have completed the Project required tests are eligible for graduation. Or they can (2) take any English proficiency examinations again and achieve the B2 level of CEFR to meet the English 須於畢業前至少參加一次英文檢定考試，且成績應達CEFR之B2高階級（各項英語能力檢測成績與CEFR之B2高階級的成績對應另行公告）；大三上學期結束前未達前述標準者，須於大四參加管理學院舉辦之8次英語自學方案測驗（上學期4次、下學期4次，如上學期或下學期4次測驗成績平均高於80分者，則免參加次一學期之測驗；如累計4次80分者，亦可免參加其餘測驗）或再次參加英文檢定考試，且成績達CEFR之B2高階級始有畢業資格。

Each undergraduate student of the College should take at least 5 professional courses (or 15 credits) taught in English prior to graduation (English training courses are 於畢業前需至少修畢5門（或15學分）本院開設之「以英語授課的專業課程」，始有畢業資格。

All Accounting Department seniors are required to take the Departmental Comprehensive Examination in Accounting during the first semester of their senior year.

The Financial Statement Analysis course is offered in both English- and Chinese-taught classes, and students may choose either option.
